THIS AGREEMENT TO RELEASE, HOLD HARMLESS, INDEMNIFY AND DEFEND INCLUDES BUT IS NOT LIMITED TO, INJURIES OR DAMAGES TO OR CAUSED BY RIDER, PARENTS, RELATIVES OF OR GUESTS OR INVITEES OF RIDER In the event rider is a minor, the parent(s) or guardian(s)shall further indemnify, defend and hold Manager harmless from any such claims by said minor child, or other person on behalf or for the benefit of or arising out of any injuries or damages of said minor, regardless of any statute of limitations or contractual limitation of actions. - 3. In the event Rider is using Rider's own horse, or a horse(s) not owned by Manager, Rider warrants said horse(s) shall be free from infection, contagious or transmittable diseases. Manger reserves the right to refuse access or use of any horse upon the premises that does not appear to Manager to be in good health, or is deemed dangerous or undesirable.
- 4. Rider, and if Rider is a minor, Rider's parent(s) or legal guardian(s) agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and / or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.
- 5. Severability If any provision or portion of this Release is held invalid, illegal or unenforceable in any respect, then such provision will be modified to reflect the parties' intention. All remaining provisions of this Contract shall be unaffected thereby and will remain in full force and effect.
- 6. Arbitration All disputes, controversies, or claims arising out of or relating to this contract shall be submitted binding arbitration in accordance with the applicable rules of the American Arbitration Association then in effect.
- 7. Non waiver -The failure by one party to require performance of any provision shall not affect that party's right to require performance at any time thereafter, nor shall a waiver of any breach or default of this Contract constitute a waiver of any subsequent breach or default or a waiver of the provision itself.
